Fees and Payment

Boarding fees are charged per calendar day – the day of drop off, the day of pick up, and any days in between. Any additional services or expenses (ie grooming, food purchases, veterinary care) will be included in the total cost, to be paid in full at time of pick up. In the case of pets that require cleanup due to reasons beyond our control (ie incontinence, parasites, unsanitary habits), a bathing fee will be charged. This does not refer to normal maintenance – wiping feet, toweling dry, clean bedding.

Care & Medical

Any medical conditions, medications, behavior issues and special instructions pertinent to the care and well-being of the animal and the safety of the Staff, have been made aware to the Caregiver in this Agreement.

Should my pet become ill or injured, the Caregiver has my full permission to have the animal treated by a qualified Veterinarian (where possible, the Veterinarian listed on this Agreement). I agree to reimburse the Caregiver for any and all costs incurred for such treatment.

The Caregiver will not be held responsible for loss, illness or injury and reserves the right to refuse services.

Delayed Pick Up

Should circumstances render that the pet is not be able to be picked up on the scheduled date the Caregiver must be notified as soon as possible. Additional boarding day rates will apply.

Abandonment

Should the Caregiver not receive instructions or communication from the Owner within 5 days of the scheduled pick up date, the dog will be considered abandoned. As such, the Caregiver assumes responsibility to rehome the animal or surrender to the SPCA.
